

YOUR WELL-BEING IS OUR PLAN

If you are enrolled in a Humana FEHBP plan, you should know that they will no longer offer commercial health plans; this includes their federal coverage.

Members of the Humana FEHB plan must change their enrollment during the upcoming Open Season.

It will not be an automatic transition, and you need to use one of the following methods:

- Agency employee page
- SF2809 (Ask your HR officer)

Open Season starts on Monday, November 13th and ends on Monday, December 11th.

Changes will become effective on the first pay period of January 2024:

- Retirees, Tribal Employees, TCC and Spouse Equity - January 1, 2024
- USPS Employees - January 13, 2024
- Most Federal Employees and OWCP - January 14, 2024

Triple-S Salud administers the Regional Plan Triple-S Salud FEHB and the National Plan BCBS FEP as different options within the Federal Health Benefit Program (FEHBP). You can use the following enrollment codes during Open Season:
